1	<p><b>Introduction</b> To review all initiatives arising from the Community Plan Action Points</p> <p>In November 2008 the North Elmham Community Planning Group was founded at a public meeting. During 2009-10 it met regularly and by Spring 2010 a questionnaire was ready for distribution to every household in the parish, with the intention that the responses would provide an objective view of people's feelings about village life. During the remainder of 2010 the results were collated and analysed, the result being the 'North Elmham Community Plan' published in April 2011 and distributed to every household. This review is based on the Action Plan within that document, and is intended to ascertain progress with the many suggested actions that were identified.</p> <p>An overall review of all suggested actions is anticipated for February 2014.</p> <p>2021 Review underway - approach agreed Parish Council Meeting September 2021.</p>	Parish Council		Short
2	<p><b>Housing</b> To look at sites in the village that could be used for Housing Association Homes and Starter Homes</p> <p>24 households had someone needing alternative accommodation now; 50 households in the next 5 years. 	Affordable housing on an exception site has started with the engagement of Broadland Housing Association to pursue the scheme. A housing needs survey is to be conducted in September 2021, which will determine the number, type and tenure of housing needed. It is likely that the affordable housing will be in part subsidised by some (probably 1/3) market housing on the same site. If there is a need for a scheme the next stage will be identification of a suitable site.

Data collected from these devices has been offered to the police and county highways to assist them in considering any additional measures. To-date the authorities have declined evaluation of this data.

Of the 773 copies distributed, 48 were completed and returned (7%). The responses are being analysed and options for improvements are being considered and costed.

	A diagrammatic sign has been installed at the entrance to the Wood showing the species of trees and a short history of the site. The entrance gate has been amended to facilitate passage of mobility scooters and buggies.
