007 Update on Affordable Housing Scheme (item 305)

008 Land Management Matters (item 306)

- a) <u>Village Green</u> The grass has been cut today. A quotation of £3.8K + VAT has been obtained to carry out the necessary work on the trees. Two other quotations are to be obtained. The annual RoSPA inspection is to take place in June. One item possibly requires attention before the visit. Mr. Phillips will discuss the matter with NGF Play Ltd.
- (b) <u>Cathedral Ruins</u> The cost of a Charles the Third Coronation seat (three seater) is £1,038. Mr. Fitzalan Howard proposed that one be purchased and this was seconded by Mr. Markwell. All in favour.
- (c) <u>Cathedral Meadows</u> Nothing to report.
- (d) <u>Broom Green</u> Mr. Labouchere advised it is planned for the pond to receive attention during the last week in June with, hopefully, the necessary machinery being supplied by Messrs. Goff and Cook.
- (e) <u>Millennium Wood (and Jubilee Wood)</u> Nothing to report.
- (f) <u>Bridleway on disused railway line and other railway linked matters</u> The footpath and Church Lane bridge are to be temporarily closed to enable the necessary work to be carried out. The permissive signs have been removed and replaced by signs referring to the word "lineside".
- (g) Prince William Wood Mr. Markwell has identified five dead trees which are well hidden.
- (h) <u>Church Meadow</u> Mr. Fitzalan Howard said that the north side of the church is very damp. The original intention was for a trench to be dug which would turn right to the graveyard. After consideration, it is proposed to dig a trench across Church Meadow with a pipe to be taken to the edge of Jubilee Wood where there is a ditch. All were in favour of this course of action.

The kitchen has been subjected to PAT. There have recently been some problems on the Playing Field and, as a result, the police are to monitor the situation. A RoSPA inspection is to be carried out in June. A communication has been received from the Walking Football Team (Mr. Mullany) who says that the pitch on which they play has been badly affected by bore holes made by rodents. He believes there is a high risk of injury through tripping up whilst playing. A request has been made for the Parish Council to examine the area in question. This has been done by the Chairman and Mr. Smith who were unable to locate any holes in the surface. The Clerk will write to Mr. Mullany to arrange a meeting to discuss the matter. Mr. Reeve, Chairman of the Football Club, will also be invited. The Chairman thanked Mr. Smith for all the arrangements and hard work in respect of the Coronation lunch. Mr. Smith wished to place on record the Parish Council's appreciation for the assistance provided by Power-Medix Electrical Services regarding the installation of the defibrillator and a number of other matters.
